# Noel Andrés Poyo

## **Biographical Statement**

Noel Andrés Poyo is a national leader in the community and economic development field with more than 22 years of experience in affordable housing, small business finance and neighborhood economic development. His career has focused on integrating low-income people and immigrants into mainstream financial services and real estate sectors of our economy as well as improving the livability and economic resilience of low-income neighborhoods and affordable housing communities. Poyo has played diverse roles in the implementation of community development projects valued over \$1 billion. His experience also includes increasing the effectiveness, sustainability and innovation of government agencies at the local, state and federal levels.

Since September 2006, Poyo has served as Executive Director of NALCAB - National Association for Latino Community Asset Builders. NALCAB is a non-profit membership organization that is the hub of a network of more than 120 community and economic development organizations that serve geographically and ethnically diverse Latino communities in 40 states, Washington DC and Puerto Rico. NALCAB's mission is to strengthen the economy by advancing economic mobility in Latino communities. Members of the NALCAB Network invest in their communities by supporting small business growth, building affordable housing and providing financial counseling. 70% or more of those served by the NALCAB Network are Latino, 20% are Black and more than 40% are immigrants. Since 2015, Poyo has concurrently served as the CEO of Escalera Community Investments, NALCAB's subsidiary asset management company, which controls social investment funds designed to capitalize affordable housing projects and small businesses.

Under Poyo's leadership, NALCAB has provided its Network members with over \$22 million in grants and a wide range of technical assistance and has trained more than 1,200 practitioners. With NALCAB's technical support, member organizations have secured more than \$400 million for affordable housing, small business and financial capability programs that has leveraged more than a billion dollars in economic impact. NALCAB has influenced how local and federal government agencies are deploying hundreds of millions of dollars for community development and disaster recovery.

From 2015-2017, Poyo served as one of fifteen members of the Community Advisory Council for the Board of Governors of the Federal Reserve System. In this capacity he participated in semi-annual meetings with the Fed Chair and Governors and provided insight to the Governors and staff of the Fed throughout the year.

Poyo advises the executive leadership of banks including JP Morgan Chase, BBVA and Capital One as a member of their respective national Community Advisory Boards. He also advises numerous nonprofit lenders and other social investors. He serves on the Board of Directors of the Center for Responsible Lending, the nation's leading research and advocacy organization focused on combating predatory lending. A graduate of Yale University, Poyo is bicultural and bilingual. He is a proud husband and father of three girls.
