Coordinated litigation among more than thirty co-plaintiffs and five related cases.

- Case challenging misclassification of workers at a nationwide freight company, resulting in an agreement to reclassify hundreds of workers across the company, and nearly \$1 million in back wages;
- Litigation challenging commercial laundry company's failure to pay overtime compensation, resulting in a settlement of \$615,00 to low-wage, immigrant workers;
- Successfully prevented termination of several employees on the eve of wage and hour trial; ultimately received favorable district court judgment ordering substantial overtime compensation, liquidated damages, and compensatory damages due to the threatened termination;
- Litigation challenging retaliatory termination of hair salon employee who complained of occupational safety issues, resulting in settlement of \$165,000 to the employee;
- Drafted successful briefs in support of the Secretary's OSHA citations against Wal-Mart for failing to ensure adequate crowd control at a Black Friday sale, which resulted in the trampling death of an employee.
