# Ismail Ramsey

## Summary

Ismail (Izzy) Ramsey is the 53rd United States Attorney for the Northern District of California, the region's chief federal lawenforcement officer. Nominated by President Joe Biden, Mr. Ramsey, with bipartisan support, was confirmed by the United States Senate by voice vote. He took the oath of office on March 21, 2023.

Nearly nine-million people—including 33 federally recognized Native American tribes—live, work, and raise their families in the Northern District of California. The district comprises 15 counties—with more than 450 miles of Pacific coastline. It encompasses three major metropolitan areas—San Francisco, Oakland, and San Jose. It spans a variety of suburban and rural areas—including the coastal enclaves of Mendocino, Carmel, and Big Sur and the agricultural communities of Napa Valley, Sonoma Valley, and Monterey. It features two national parks—Redwood and Pinnacles—as well as Point Reyes National Seashore and Golden Gate National Recreation Area. And it is home to more than 300 public companies located in the technology and innovation capital of the world—Silicon Valley.

To uphold the rule of law and ensure public safety, the 130 lawyers and more-than-a-hundred support staff who work in the United States Attorney's Office prosecute criminal violations of federal law, including securities, mail, and wire fraud, public corruption, civil rights violations, economic espionage, domestic and international terrorism, organized crime, drug trafficking, money laundering, racketeering, gun trafficking, cybercrime, trade secret theft, Endangered Species Act violations, environmental pollution, and tax evasion. To empower crime victims, they enforce judicial victim-restitution orders. And, to protect the public treasury, they defend all civil lawsuits brought against the federal government and litigate actions to collect judgments on behalf of taxpayers.
