
# ANN E. CARLSON

Teaching: In 26 years at UCLA School of Law, significant professional accomplishments include:

Starting the first law school center focused on Climate Change with an annual budget of \$1.5 million and an endowment of almost \$14 million. Expanded faculty from two to ten and began a specialization for students. Currently serve as faculty co-director, responsible for supervising a staff of 8 focused on training the next generation of environmental law students; helping develop solutions to environmental and environmental justice challenges through policy analysis and research; educating the public through publications, events. Also co-manage a distinguished Board of Advisors, engage in fundraising and donor management. The Emmett Institute has propelled UCLA Law's environmental program into the forefront of law school environmental education, leading to a ranking of 4th in U.S. News and World Report annual specialty rankings.

Teaching Property, Environmental Law, and a Climate and Energy Law workshop and winning three teaching awards, including the UCLA Eby Award for the Art of Teaching and the UCLA Distinguished Teaching Award, the highest teaching honors bestowed by the University;

Writing numerous articles and two books, including a leading casebook on Environmental Law and a co-edited volume on the Clean Air Act; three articles have been selected as among the top five published in the field in an annual compilation;

Co-founding the blog Legal Planet, focused on cutting-edge environmental issues; frequent media commentator, including appearances on 60 Minutes, MSNBC, Marketplace, NPR, local and international television, and quotes in leading publications including the New York Times, Washington Post, New Yorker, Guardian, National Geographic, L.A. Times, Vox, and Atlantic;

Providing extensive service to UCLA Law School, the UCLA campus and the UC system, including serving as the law school's Academic Vice Dean twice; chairing UCLA's Committee on Academic Personnel; chairing numerous internal committees; serving on the UC President's Global Climate Leadership Council (GCLC) and chairing a subcommittee to implement the system's carbon neutrality goal. As

Academic Vice Dean, responsibilities included supervising the merit and promotion process for all ladder-track faculty, serving as a strategic advisor to the Dean, and providing important budget guidance through close consultation with the Law School's Chief Financial Officer. As Chair of the Committee on Academic Personnel after three years of membership on the committee, responsible for reviewing merit and promotion cases for all campus members of the Academic Senate across all departments, including the Medical School. As a member of the UC President's GCLC, advise the President and UC staff on campus goals for carbon neutrality (carbon neutral by 2025); as chair of the subcommittee convened stakeholders from across the system's ten campuses to identify and recommend solutions for obstacles to implementing the carbon neutrality goal. A number of our recommendations have been implemented, including revising system-wide building policies to require electrification where possible; and including carbon neutrality progress as part of annual Chancellorial evaluations;

Named Shirley Shapiro Professor of Environmental Law in 2009, eligible next year for promotion to Distinguished Professor (reserved for most senior and accomplished professors in the categories of research, teaching and service).
