Summary

Hampton has been an adjunct faculty member at Duke Law School and published an article in the Harvard Law Review. Following law school, he clerked for an esteemed federal judge (J. Dickson Phillips, Jr.) on the United States Court of Appeals for the Fourth Circuit.

Hampton is also a contributing writer for the Atlantic.com, and served as the lead legal analyst for NBC News and MSNBC during the federal criminal trial of a former Vice Presidential candidate and U.S. Senator (U.S. v. John Edwards).
