Amounts of income are not required for a spouse's earned income (excluding honoraria).

### 6. Other Assets and Income

Additional exceptions apply.

### 8. Liabilities

Part 8 discloses liabilities over \$10,000 that the filer, the filer's spouse or dependent child owed at any time during the reporting period.
