Prior to SBA, Dilawar championed American businesses as Special Representative for Commercial & Business Affairs at the State Department. As State Department's top commercial diplomat, Dilawar advocated for U.S. companies to compete and win abroad to help ensure U.S. strategic competitiveness. He mobilized U.S. private sector to support Ukraine in the wake of Russia's invasion, advocated for commercial deals in strategic sectors such as energy, aviation and defense, and advanced tech, and pushed for better business environments in 24 bilateral visits across the globe.

Before joining the Biden Administration, Dilawar was CEO at Lumiata, an AI healthcare company focused on reducing healthcare costs and improving patient outcomes. Freshworks went public in September 2021. He served on President Obama's White House Commission on Asian Americans and Pacific Islanders (AAPIs) and chaired the White House Initiative on AAPIs' Economic Growth Committee. In that role, Dilawar led the administration's engagement with small businesses across the U.S. after the passage of the American Recovery and Reinvestment Act of 2009.
