- Increased turnout by 49 percentage points across 8 counties, including 3 of the largest metropolitan areas in the state, improving upon 2016 margins
- Coached a team of Regional Organizing Directors around problem solving and workshopping organizers' performance, and helped overcome management and performance challenges.
- Organized one on one meetings with the regional's weekly to discuss metrics, and work through

  unparalleled way.

- Directed the field program for Genesee County, managed a team of 4 field organizers; Organized
  creative virtual events via zoom and google hangout to recruit and train volunteers and increased the
  volunteer activity base.
- Coached a team of organizers daily on hard organizing skills such as: strengthening the hard ask, relational organizing, improving the volunteer experience, and helping them ask for everything they need when recruiting for volunteer events and building strong volunteer leadership teams.
