During this time, coordinated with advocates to organize a political advocacy campaign against DOL's proposed 2017 Tip Rule, including: submitting a letter to DOL demanding an extension of the public comment period; writing a Senate Democratic Caucus sign-on letter objecting to the Administration's efforts to conceal analysis from the public; co-drafting a bicameral comment letter with the House Education and Labor Committee objecting to the proposed rule; engaging directly with Secretary Acosta's office to resolve the issue by drafting legislative language and negotiating the language; securing the Secretary's commitment to permanently suspend the rulemaking and support compromise legislation amending the Fair Labor Standards Act (FLSA) to prohibit employers from keeping workers' tips, which was enacted into law during a Republican-controlled House, Senate, and White House; and writing a comment letter on DOL's subsequent 2019 proposed Tip Rule interpreting the new legislative language to ensure the correct interpretation
- Handling the nominations of senior DOL officials, including Secretary Acosta and Secretary Scalia, Solicitor of Labor O'Scannlain, and Wage and Hour Division Administrator Stanton
- Collaborating with the LHHS Appropriations Subcommittee to ensure adequate funding levels for DOL
 enforcement and grant-making, to exercise oversight of DOL use of funds and prohibit negative DOL
 actions through report language, and to resist proposed anti-worker appropriations riders
- Drafting comprehensive bills on items such wage theft, overtime pay, arbitration, and the fissured workplace
- Assisting the Senate Democratic Leader in drafting caucus white papers, e.g., The Senate Democrats' Jobs and Infrastructure Plan for America's Workers, and drafting related legislative text, e.g., wage standards included in the America LEADS (Labor, Economic competitiveness, Alliances, Democracy and Security) Act
